## **Chair's Commentary**

As I embark on my third year as the Society's Chair, I would like to thank members for their continuing support, not only for me but also for my fellow committee members, the majority of whom have been engaged in the Society's activities for considerably longer than I have, and whose expertise I find invaluable. It is a great privilege for me to continue as the Society's Chair, following members' supporting votes at April's Annual General Meeting. I am also delighted to welcome formally Bob Hollis to the committee. Bob is taking over the heritage and conservation brief, formerly held by Rob Austen.

#### Local Plan update

In the last newsletter, I reported that late April / early May was the anticipated date for the Council's publication of the Pre-Submission Draft Plan. There has been some slippage in the timetable: the Council's Licensing and Planning Policy Committee meeting scheduled for 25 April was postponed, and the draft plan was not on the agenda for the 8<sup>th</sup> May meeting. That meeting nevertheless had several agenda items of considerable interest, namely the Council's Local Plan Annual Monitoring Report 2016-2017, the Council's response to the Government's consultation on the revised National Planning Policy Framework (NPPF) (to which the Society also submitted a response, more details below) and – of particular interest insofar as it anticipates draft policies in the new draft local plan - an agenda item, 'Making Efficient Use of Land - Optimising Housing Delivery'. The next meeting of the Licensing and Planning Policy Committee is scheduled for 7<sup>th</sup> June and we await agenda items with interest. We will provide local plan updates to members via our website, Facebook page and Twitter account.

#### **Responding to the Government's NPPF Consultation**

All local plans should be consistent with the National Planning Policy Framework (NPPF), and the Government has been consulting on what the revised NPPF should say. Key points from the Society's response to this consultation include a desire for greater emphasis on social sustainability, and not on 'growth at all costs', support for all viability assessments for new development to be made publicly available, support for reinforcing planning's links to health and the recognition of the importance of parks, open space, sport and recreation, concern about proposals for minimum density standards in terms of adverse impact on

daylight / sunlight levels on health grounds, support for strengthened protection for ancient woodland and concern not to undermine existing policy on the Green Belt. Indications from central government are that the revised NPPF will be published in July. The new NPPF will have implications for the policies in the Council's new local plan.

### **Parliamentary Meeting on Conservation Areas**

On 8th May, I attended Civic Voice's All Party Parliamentary Group meeting for Civic Societies in Portcullis House for a discussion, 'What is the future for our conservation areas?'. This was part of the 'Big Conservation Conversation', a national campaign to improve awareness and understanding of the nature and value of conservation areas and to seek greater resources and protection, particularly for those areas at risk. Epsom has 21 Conservation Areas, all of which are likely to come under increasing development pressure. The Society is concerned that the character and local distinctiveness of our conservation areas is retained despite the considerable challenge of accommodating increased levels of housing need following central government's new standard model for its calculation. #### PLANNING APPLICATIONS

Bradford House, East Street: In 2014 permission was for granted the redevelopment of the two buildings to the north of Majestic Office Wine and The first, Outlet. Crossways House. completed was as ground floor offices with four floors of student



accommodation over; the second, Bradford House was not, because of market conditions. A proposal has now been submitted for it to be replaced by a new building, apparently to be called Sunnybank House, of basement and six storeys over to be used as ground floor offices and 99 student bedrooms, for which there is an established demand by the University of the Creative Arts.

The design of the proposed build is undistinguished and fills too much of the site and there is no provision for very necessary landscaping. The earlier permission had been for residential use, the urgent need for which must be balanced against student accommodation. We have made these points and await a decision.

The former Police Station, Church Street: The planning department has held discussions



with the developer and useful amendments have been made. Adjustments made have been to co-ordination improve with future development of the Ambulance Station and Clinic. In this artist's impression, important changes in design have also been made to reflect local distinctiveness. including slated mansard

roofs and ground floor plinths and these will be welcome improvements by softening the rather square and unfriendly appearance. We have written accordingly and made some further suggestions, but pointed out that problems of parking and affordable housing remain.

2 Pine Hill: This house, in a prominent position at the entrance to the Woodcote Estate, has deteriorated into a 10-bedroom HMO (house in multiple occupation). An application by the owner to extend it into a block of apartments caused much criticism and was withdrawn last year. A revised proposal has now been made involving the addition of a new upper eaves floor to create eight 2-and 3-bedroom flats on



three floors. The extension, with its increase in bulk, would be overbearing and change a well-designed house into a solid block; this would be unacceptable and out of keeping with the character of the estate. The present poor condition of the house cannot justify such a proposal and we have written to say that planning permission should be refused.

101 College Road: This is a substantial comparatively modern house opposite the main



entrance to Epsom College and it is proposed to demolish it and build a three-storey block of nine 2-bedroom flats covering a large part of the site. We believe this would be out of keeping with the location and would be overdevelopment by reason its bulk and height. We have therefore said that we agree with local objections and could not support the grant of planning permission.

# A POLICEMAN'S LOT.....

The Metropolitan Police was the first formal, fully operational police force in the country established by Sir Robert Peel and operating within seven miles of Charing Cross. This area included part of Surrey as it then was and gradually additional parts of the county were added including Banstead, Warlingham, Coulsdon and Epsom.

In 1835 the Municipal Corporations Act allowed cities and towns to form their own police forces. In 1836 Guildford set up its own force and Godalming followed a few years later. A meeting of the Guildford Watch Committee appointed nine constables and a part time superintendent constable – he was also a baker - received £15 p.a. It was also decided that the constables be provided with a uniform similar to that worn in London at cost not to exceed five guineas.

Over the years attempts to establish forces in other parts of the county were started but it was not until the County Police Act of 1839 - known as the Permissive Act - that serious attempts were made to form a Surrey Division. In 1850 the Rural Police Committee met at Reigate and decided to take evidence regarding the formation of a police force in Surrey. In 1851 the Surrey Constabulary became operational with 70 police officers including five superintendents. Men of the right calibre were selected and in 1854 new headquarters were completed in Woodbridge Road, Guildford. Various county police stations were opened and superintendents were stationed at Reigate, Dorking, Godalming, Farnham and the headquarters. Four classes of constables were established but initially no sergeants.

The railway line to Portsmouth caused scores of construction workers – navvies - to move into Guildford and an Inspector Donaldson was killed in a riot which followed. In 1863 Reigate formed its own force and this force remained independent until 1947 when it amalgamated with the County Force.

In 1932 Sir Malcolm Campbell, of Bluebird fame, took charge of a mobile section and a few years later Donald Campbell joined the Special Constabulary as a motor cycle dispatch rider and in 1935 a Special Constabulary Air Unit was set up at Redhill Aerodrome.

There is not space to give the full history of Surrey Constabulary which in 1993 became Surrey Police and which gradually cemented a partnership with Surrey County Council to stimulate and assist community safety and crime prevention across the county.

Special mention must be made however of the boundary changes made in 1998 when Surrey took over the Boroughs of Epsom and Ewell, Spelthorne and the remaining areas of Reigate and Banstead and Elmbridge. This meant that Surrey, for the first time, had to police one of the biggest sporting events in the world, the Epsom Derby.

In 1948 the Force purchased, at a cost of £17,500, Mount Browne in Guildford, and this remains the Surrey Police H.Q. It was opened in 1949 by The Right Hon. J. Chuter Ede M.P., the Home Secretary, former Charter Mayor of Epsom and Ewell and former Chairman of Surrey County Council. It has very recently been announced that Surrey Police will be moving out of Mount Browne. The new headquarters are likely to be in the Dorking/Leatherhead area and it will take 4 to 5 years for the move to be completed.
